

the loving God (Mt 16:13-18). Upon this confession, Jesus begins to tell His disciples of His impending trial and crucifixion. Of course, the Gospels tell us that much of what Jesus said confused the disciples, and likely His predictions of the trials He would face were no less so. We also hear the centurion proclaim at Christ's crucifixion, "Truly, this man was the Son of God" (Mt 15:39). Only after the death, resurrection and ascension of Jesus and the coming of the Holy Spirit at Pentecost did the Apostles understand fully who Jesus was. He was the Dearly Beloved Son of God, who offered His life for our salvation. This is the core of our faith as Catholics.

So what does all of this tell us? As followers of Christ, we are called to be like Him. Just as Christ was Light to the world, so are we to be. Christ did not hide Himself away on caves, on mountains, or in the temple. He took His message of forgiveness and love to the people. Likewise, what we experience at church cannot, and must not, stay in church. We are called to bring the Good News of salvation to the world.

We do this by sharing the message verbally, but also by acting in loving ways. When we do, we show that we truly care for one another's well-being. Following the example of Jesus, we are to be charitable to one others, putting others and God first in our lives. This extends beyond family and close friends. We are to give our love to all, even our enemies. When we reflect the light of Christ to others, we are, in a sense, "transfigured." We are made to shine forth, as beacons that can bring hope and healing to others and to the world.

## PRO-LIFE ACTIVITIES REPORT

I find it hard to believe that President Obama and the DNC has raised over \$86 million in campaign funds in

the past three months, May-July. This might make it harder, but not impossible, to get a pro-life president in the White House in 2012. The success that the Republican Party had in 2010 might mean that if this is what the people want, maybe then too, they will be there with their votes to remove President Obama from the White House.

The AUL (Americans United for Life) is doing its part to give Congress all the evidence they need to prove that Planned Parenthood has partaken in "criminal child sexual abuse, failure to RU 486 abortion drug has killed dozcomply with parental involvement laws, assisting those engaged in prostitution and/or sex trafficking, misuse of federal funds" and other misdeeds. Today, there are a number of members in Congress who have requested an investigation into Planned Parenthood. Big bucks, on the side of Planned Parenthood, must be at work from allowing this to have already taken place.

Some bishops are asking Catholics to think, long and hard, about voting for candidates who may be supporters of the pro-choice movement. I, too, ask you, members of this Council, to do the same. Even when donating money to the Church, make sure you know where the money will be distributed. In the past, some had gone to pro-homosexual and pro-choice organizations. This is so counterproductive.

Catholics have a moral obligation to help the pro-life movement. If abortions do not bother you, what is your feeling about Planned Parenthood undermining parents and promoting sex to kids? The pro-choice movement states that those of us who wish to protect the baby are placing the life of the woman at risk. Why are they not mentioning that the dangerous ens of women and injured more that a thousand? Does the pro-choice movement tell a woman that having an abortion increase their chance by 34% of having a premature child the next time she becomes pregnant and that she may suffer from other pregnancy complications (according to a recent study conducted in the United Kingdom)?

One should wonder why it is taking so

long for the lawmakers to agree that there is proof that this unborn child is a "person", and therefore entitled to the same rights as any other person. Supporters of the "personhood concept" are also sure that this will give clear meaning to protecting disabled persons and the elders. Remember, A Life at Conception Act declares unborn children as persons defined by the 14th Amendment to the Constitution. I pray that Cardinal Wuerl will see to it that Catholics under him will be informed of their duty to protect the innocent.

Although Jewish law prohibits abortion, all four progressive Jewish movements - Reform, Conservative, Reconstructionist, and Humanistic are members of the Religious Coalition for Reproductive Choice and hold that "abortion is permitted and sometimes required to save a woman's life". This confirms their voting position in the past. However, they all feel that any women that goes to an abortion clinic deserves to be told fully about their options: adoption, abortion, and continuing the pregnancy. Most of us know that this is not what usually takes place at abortion clinics.

## CHURCH ACTIVITIES REPORT

Most of us are aware that there has been a reduction of Catholic priests and religious in this country, but it seems to be more prevalent in Europe, especially in Germany, Austria and Switzerland. In Europe, an increasing number of theologians are disturbed at what they see happening. They believe that child abuse by clergy as the main cause. They ask that celibacy be discontinued and to ordain women, thinking that this would put an end to this "sin of the Church".

Why do these theologians not see that this would be a departure from the Catholic faith? One has to wonder if the Church could change. It has been in existence for almost 2000 years, and it seems that this makes it somewhat hierarchical and may not be able to change. Time should tell.

It has been documented that child abuse is occurs also in the Protestant faiths, and at a greater rate even with their removal of celibacy and with having women priests. Knowing this you have to wonder how these theologians came to the conclusions they did. Their recommended solutions have not helped the Protestant church any. Remember this, 1.7% of the Catholic clergy has been found guilty of pedophilia. Ten percent of the Protestant ministers have been found guilty of pedophilia. The media would have you think that this is a problem only with the Catholic clergy.

Those supporting same-sex marriages say that it is the right thing to do. I say that "being a truly Catholic person is the right thing to do," knowing that many would not agree with me. What they should be saying is that this is about "giving the homosexual-rights movement what it wants". In an article I read by Joseph Dooley of Glen Burnie, MD, he stated that if you can change the meaning of one man-one woman marriage then what about the basis, legal or moral issues, of forbidding acts of incest and polygamy also on the basis of equality. This is an example of the tail waging the dog. The government has been telling us that we cannot pray in public school and should not do many other things because it may offend

some minority group no matter how small a group they may be.

Recently, when the governor of Maryland said that he would support same-sex marriage, the Archbishop of Baltimore, Edwin O'Brien, sent a letter to the Governor O'Malley stating, "It is especially hard to fathom your taking such a step, given the fact that our requests last year for you to sponsor legislation to repeal the death penalty and support students in Catholic and other nonpublic schools went unheeded."

Remember that our governor says that he is a Catholic. O'Malley's response was, "I do not presume nor would I ever presume as governor, to question or infringe upon your freedom to define, to preach about and to administer the sacraments of the Roman Catholic Church, but on the public issue of granting equal civil marital rights of same-sex couples, you and I disagree...I look forward to working with you on other issues of mutual agreement." So much said about some of our so-called "Catholics" in politics.

It is hard to comprehend how those that support "freedom of expression" can vary so greatly. Some may say that though it is wrong to pray in our public schools, it is all right to slander the Catholic faith and find no fault in this. There was an art exhibit in Manila, Philippines in which a statue depicting Christ with the face of Mickey Mouse was felt by some acceptable. Thankfully, since their population is 85% Catholic, many in that city did not think so and had the exhibit closed down. An atheist is suing the city of New York for thinking of displaying two beams joined at a right angle, resembling a cross, found in the ruins of the Trade Center on 09-11, saying that it should not be displayed in their new memorial museum because of its Christian connotation. Also mob violence involving religion can be found today in more than fifty countries. It is no wonder that we find so many speaking against the Catholic faith every chance they can. There seems to be far too much unrest, and I am sure that it may only get worse. Let us pray that this will not happen. God Bless.

## **Cardinal Burke Addressed the KofC Supreme Convention**

Cardinal Raymond L. Burke, Prefect of the Supreme Tribunal of the Apostolic Signatura, addressed the Order's Supreme Convention on August 2 in Denver.

He noted that we are living in "a society in which, in many respects, morality has ceased to exist." He continued: "In many so-called advanced nations, we witness an increasing tendency to deny to citizens the most fundamental right, the right to observe the dictates of one's own conscience, formed through right reason and the teaching of the Church. We witness the phenomenon in the language of political leaders who profess to be Catholics and yet vote for legislation which violates the moral law, claiming to hold personally to what the moral law demands but, at the same time, to be obliged by their political office to follow a different law in making decisions for those whom they represent and govern."

Religion, he continued, "is not a problem for legislators to solve, but a vital contribution to the national conversation."

The Cardinal encouraged us to be hopeful, saying, "If we are, from time to time, discouraged in our struggle to meet the high standard of ordinary Christian living on our time, let us turn to Our Lady of Guadalupe, begging her intercession and imitating her total trust that God's promises of salvation to us will be fulfilled."

## On Being a Catholic American Citizen

Virtually every reader of this article can say, "I am a Catholic American citizen." All those who can make this claim are most fortunate. But how many have thought about the full meaning of this statement or of the responsibilities that it implies?

Citizens are members of a nation-state. They have rights and are entitled to the benefits which flow from them. This is different from subjects who may enjoy similar benefits, which are granted as a privilege from a higher authority. Citizens, especially under more democratic forms of government, can dissent and criticize the government and can replace the governing body through free and fair elections. Subjects, with restricted or no rights, as in a

dictatorship, an oligarchy or a strong monarchy, may have limited privileges to criticize the government, and can replace the rulers only through violent overthrow, as occurred in the French and Russian Revolutions.

In return for the rights they possess, citizens are expected to give full loyalty to the state, accept the obligations of helping it function and survive, and actively participate in its political and civic life. They should understand the meaning of and support the nation's constitution, ac-

cept the authority of the elected government, promote respect for the law, and participate in public consideration of matters of local and national interest.

American citizens are fortunate because they enjoy numerous liberties and rights, including freedom of speech and of religion, popular elections, representative assemblies, and the rule of law. Their nation has a constitution which defines the form and structure of government, limits the power of the central government, and makes clear that the government's power rests in the people.

In America, which was organized by the people, for the people, and is of the people, the success or failure of the government is everyone's responsibility. As a result, American citizens incur many essential obligations. They may be called to serve on juries, encouraged to engage in military service, required to pay their fair share of taxes, and expected to respect the rights of those with differing points of view.

Catholic American citizens should carry out their obligations of citizenship within a framework of religious beliefs and teachings that shape and guide their participation in the nation's public life. Their thoughts, decisions and actions should be inspired by their faith. Catholics who truly believe in their faith must assimilate it into their inner being, allow it to shape their consciences, and use it to form their way of life.

In the democratic, but pluralistic and secular American society, the common good requires a respect for people with different beliefs and a willingness to find common ground whenever possible. This does not mean, however, that Catholics should compromise or be silent on fundamental issue of faith or human dignity. Catholics can serve the nation best by living their faith openly and unashamedly.

They may do so in many ways. They may work to mold public opinion, frame issues, and encourage others to act, vote and participate in public discussions on matters that affect Catholic precepts. They should help to develop among members of the community a moral conscience on political issues, support the passage of laws that are just and consistent with the teachings of the faith, respect the dignity of each person, and promote the virtues and morality that underlie the founding pre-

cepts of the nation. They should practice the Catholic religion conscientiously and faithfully, be loyal to the Magisterium, and conduct their duties of citizenship consistent with Catholic virtues and Church teachings.

With the continued secularization of this nation, the growing view that religion should be a private matter, and so many Catholics in public life opposing Church teachings, the Knights of Columbus can be a potent force for good. Cardinal Amleto Giovanni Cicognani, who served as Apostolic Nuncio to the United States for 25 years and as Papal Secretary of State for two popes, addressed the 60th Supreme Convention of the Order in 1942. With the family then under siege from economic and social forces, he said:

"[T]he Knights of Columbus should be prepared to face their duty. Proclaim by all the means at your disposal that to conspire against the solidity of the home, to weaken its sacred bond of union, to deny it the means of decent livelihood, or in any way whatever to interfere with its God-given mission of physical and moral formation, is nothing else than a deadly attack on the security of the nation

## Life Insurance Awareness Month

itself. In recent years, unfortunately, ghastly wounds have been inflicted on family life. Redouble your zeal, then, and firmly united in your apostolate, show yourselves loyal Catholics and upright citizens, fighting like faithful knights this holy crusade for God and Country."

In the succeeding decades, conditions have worsened, not only for the family, but for virtually all moral concepts of society. A counterforce is needed. The Knights of Columbus, serving as the foot soldiers of the Catholic Church, can be the vanguard of that movement. In a statement that is as relevant today as it was when made in 1947, Cardinal Cicognani, provided a mission for that counterforce. He said, "[A]s sons of God, you must be transformed, and in turn transform the world, by a fervent living of the Christian faith. That is the will of the Lord." Will we, as Knights, assume the gauntlet?
